

PLEASE REFER TO THIS OFFICE MESSAGE OF EVEN NUMBER DATED 18.03.2015 REGARDING CLERANCE OF EXTRA RUSH OF DELEGATES FROM ZONAL RAILWAYS TO NEW DELHI AND BACK FOR THE DELEGATES ATTENDING 59TH GENERAL COUNCIL MEETING OF NFIR TO BE HELD AT NEW DELHI ON 28TH & 29TH April 2015 (.) IN THIS CONNECTION, GENERAL SECRETARY NFIR HAS REQUESTED FOR RUNNING OF SPECIAL TRAINS AND ATTACHMENT OF ADDITIONAL COACHES IN REGULAR TRAINS FROM ZONAL RAILWAYS TO NEW DELHI AND BACK FOR THE DELEGATES/ PARTICIPANTS (.) ZONAL RAILWAYS SHOULD MAKE SUITABLE ARRANGEMENTS TO CLEAR THIS EXTRA RUSH OF TRAFFIC OBSERVING THE DUE PROCEDURE PROVIDED THE SAME IS JUSTIFIED AND OPERATIONALLY FEASIBLE IN COORDINATION WITH NORTHERN RAILWAY (.) IT SHOULD BE ENSURED THAT THE DELEGATES ARE HAVING VALID TRAVELLING AUTHORITY, SUFFICIENT NUMBER OF EMPLOYEES HAVE TAKEN THEIR OWN PASSES/LEAVE FOR THE PURPOSE, WAITLISTED AND CAN BE SPARED BY THE ADMINISTRATION (.)
