SUBJECT:- Payment of enhanced Monetary Allowances attached to pre and post independence Gallantry Awards

REFERENCE:- This office Important Circular no. 2, bearing file No. even dated 24/7/2008 and Circular No. 5, bearing file No. even dated 12/12/2008.

Consequent on the issue of letters of same No. i.e. 7(119)/2008-D (AG) dated 30th March 2011 (reproduced as Annexure 'A' and 'B' respectively to this circular) by Govt. of India, Ministry of Defence, the rates of pre-independence gallantry award and post-independence Gallantry Awards have been revised w.e.f. 30th March 2011.

- The payment of monetary allowance attached with gallantry award may please be made to all recipients at revised rate, irrespective of rank and income.
- (a) The other terms and condition of payment of monetary allowance attached to pre-independence Gallantry Awards will continue to be governed by the G.O.I., M.O.D. New Delhi letter no. 7 (67)/92/D (AG), dated 19-4-1999 (Annexure-C) and No. 7(42)/2006/D(AG) dated 14th May,2008(Annexure-D).
- (b) In case of Post Independence gallantry awards, the payment of enhanced monetary allowance will be subject to all other terms and conditions contained in GOI MoD letter No. 3(6)/93/D (Cer), dated 31.01.1995(Annexure-E) and No.7(32)/2007/D(AG) dated 14th May, 2008(Annexure-F) as amended from time to time.
- 4. The terms and condition for payment of monetary allowance on the authority of Pension Payment Order (PPO) notified by this office in above categories of cases is stated in brief in following Paras
- I. The allowance will be admissible to the recipient of the award and on his death to his widow lawfully married by a valid ceremony. The widow will continue to receive the allowance until her re-marriage or death. The payment of the allowance will, however, be continued to a widow who remarries the late husband's brother and lives a communal life with the living heirs eligible for family pension. Ordinarily the widow who had first married the deceased recipient shall receive the allowance, but with the special sanction of the Government, the allowance may be divided equally between the lawful widows of recipients. Payments to all widows shall cease when the allowance to the first widow terminates.
- II. When the award had been made posthumously to a bachelor, the monetary allowance shall be paid to his father or mother, and in case the posthumous awardee was a widower, the allowance shall be paid to his son below 18 years or unmarried daughter as the case may be.
- III. The monthly monetary allowance will be paid in respect of all gallantry awards received by an individual.

IV. The above monetary allowance will not be taken into account for computing dearness relief.
