Sub: Fresh empanelment of Private Health Care Organization HCOs and revision of package rates applicable under CGHS, Ahmedabad.


The undersigned is directed to state that CGHS had initiated action for fresh empanelment of private HCOs under CGHS and also for the revision of package rates to be paid to HCOs, by floting tender for the sane. On the basis of the responses received, rates for various procedures/treatments/investigations have been uploaded on the website of CGHS: www.mohfw.nic.in/cghsnew/index.asp. Similarly, a copy of the agreement containing the terms and conditions of empanelment has also been uploaded on the above quoted website of CGHS.

The approved list of the HCOs for empanelment under CGHS, Ahmedabad as per the terms and conditions of empanelment and MOA signed between CGHS and HCOs is enclosed herewith.

The revised rates and terms and conditions as mentioned above will come into effect from 17th November, 2014. The empanelment shall be for a period of two years from date of issuance of this order. The HCOs already on the panel of CGHS, Ahmedabad which do not find their names in annexed list of empanelled HCOs are allowed to continue on CGHS panel till 30th November, 2014 at old CGHS rates to facilities the patients who are already admitted/permitted, to continue with their treatment course.


